Change from "Mandalay" fabric to "Cobblestone"

Information:

The fabric produced by Chatham known as **Mandalay** is no longer approved for use on meetinghouse projects effective April 29, 2004. A new pattern has been developed to take its place by the name of **Cobblestone** (available through Silver State Suppliers).

All <u>existing orders</u> which specify Mandalay <u>that have not yet been filled</u> may or may not be changed to the new fabric depending on current order status. Purchasing will coordinate with each vendor <u>by project</u> to determine status of existing orders and ensure that coordinating product (folding chairs, opera seating, pews) for a given project are filled with the same fabric – whether that be Mandalay or Cobblestone. If you have questions or concerns regarding your orders, please contact Todd Sorensen in purchasing at 801-240-1215.

PRG item numbers that previously specified the Mandalay fabric will remain the same, but will now be filled with the corresponding substitute in Cobblestone.

Fabric cards for the Style & Furnishings Selection Handbook for Replacement Projects will be provided by headquarters and distributed in June. Samples for the Pre-Set Color Scheme Selector kits (PM's only) will also be distributed in June. Samples for color boards will not be available until mid-May. Requests for samples for color boards should be directed to Manoli or Ted at Silver State Suppliers (800-453-5777). Until these are available, the Mandalay fabric may continue to be shown on sample boards.

The new fabric has been designed to mimic the Mandalay fabric, but in a flat woven texture rather than the current chenille (fuzzy texture). Until samples are available, please continue to refer to the Mandalay pattern for reference when making decisions regarding pattern and color.

The new pattern and colors correspond with the Mandalay pattern and colors as follows:
