The **Priority Level** is intended to identify four levels of implementation for current projects in the late design phase or construction phase. Current projects in the planning phase or early design phase should incorporate all Changes where applicable. **Level 1-Critical Priority:** Implement Change even if building is near Substantial Completion; **Level 2-High Priority:** Implement Change may require minor additional cost - if Change will require significant additional cost or time, Change is left to PM's discretion; **Level 3-Standard Priority:** Implement Change at PM's sole discretion. **Level 4-Low Priority:** Change should not affect cost or schedule. Implement Change.
