Level 1 - Critical Priority: Implement Change even if building is near Substantial Completion; Level 2 - High Priority: Implement Change even when Change may require minor additional cost - if Change will require significant additional cost or time, Change is left to PM's discretion; Level 3 - Standard Priority: Implement Change at PM's sole discretion. Level 4 - Low Priority: Implement Change as appropriate to phase of project. Change should not affect cost or schedule.
